TUITION & FINANCIAL INFORMATION 2018-2019 SCHOOL YEAR

APPLICATION FEE: New Student - \$75 per student

This non-refundable fee, which covers the cost of processing an application, needs to be submitted with each application to MCA.

NEW STUDENT REGISTRATION FEE: \$175 per new student. This fee covers testing, orientation, interviewing, and billing. It will not exceed \$350 per family. Should MCA deny admission, then this fee will be refunded.

STUDENT RESOURCE FEE: \$350 per student
This fee covers textbooks and annual testing purchases.

DEVELOPMENTAL FEE: \$200 per student
This fee covers the continued growth and development of MCA programs.

TUITION (JUNE 1 – MAY 31):

Elementary School (K-5th grades) - \$4,120 per year
Middle School (6th - 8th grades) - \$4,275 per year
High School (9th - 12th grades) - \$4,430 per year
Tuition may be paid in full or paid monthly over a 12 month period. If you pay in full by June 15, you will receive a 2% discount on tuition. Monthly payments are due no later than the 15th of each month.

TOTAL COSTS = Tuition + Fees (Student Resource & Developmental)/12 months:

Elementary School (K-5th grades) - \$389.25 per month
Middle School (6th-8th grades) - \$402.25 per month
High School (9th-12th grades) - \$415 per month

NOTE: Monthly payments for the 2018/2019 school year will begin June 1, 2018.

LUNCH COSTS: \$2.75 for a hot meal prepared on site daily and \$.75 for either milk or bottled water. Students may bring their lunch.

TRANSPORTATION FEE: \$30 per week for a round trip, \$15 one way per week or \$10 per day for occasional use.

AFTER SCHOOL CARE COSTS: \$45 per week or \$10 per day. After School Care is a service for those parents who cannot pick their children up immediately after school. All students remaining on campus after school hours will be signed into ASC at 3:15 p.m. After School Care needs should be designated as weekly or occasional during Orientation. ***After School Care closes at 6 p.m. and there is an additional charge for students not picked up by 6 p.m.***

WITHDRAWAL FEE: \$500 per student

You are enrolling your child for the entire year; therefore, budgets and teacher contracts are set accordingly. The early withdrawal of a student will create an opening which MCA may not be able to fill with a viable student. Students are not considered withdrawn until a completed Withdrawal Form has been received by the Principal. It is our policy to not release any report card, etc., if the withdrawing family has an outstanding balance including the withdrawal fee.

RE-ENROLLMENT FEE: Families should re-enroll their child(ren) on Gradelink by the following date. Otherwise families will be invoiced as follows: (This is a non-refundable fee.)

\$0 if re-enrolled by February 28, 2018
\$50 if re-enrolled by April 30, 2018
\$100 if re-enrolled beginning May 1
